- vi) If the Director is a working Director;
  - a. A Terms of Engagement must be completed;
  - b. An ID Card or Passport must be provided (*Original or Certified True Copy\**);
- vii) If Director is a Non-EU Citizen a Work Permit Application must be completed;
- viii) £69.00 Registration Fee.

**All Businesses and Self-Employed Persons are required to register with the Income Tax Office and Department of Social Security before registering with the Department of Employment**
