## Government delivers over 150 electoral commitments in first year

The Government has delivered 151 electoral commitments in its first year in office.

This has come about as a result of hard work by Ministers and public servants to push forward with the programme which the GSLP/Liberals were elected to implement last year.

The commitments differ in scale and in nature. Some of them are simply a case of honouring the promises made by the previous administration. Other commitments involve the use of public expenditure or the deployment of Government assets and resources. For example, the provision of a children's play-park in Moorish Castle Estate and the provision of a bus service to Both Worlds fall into this latter category.

A number of these pledges were delivered at the time of the budget earlier this year. This includes the reduction in personal tax and in business rates as well we the increase in disability allowance.

There are a number of commitments now in place that relate to the Government's agenda for openness and transparency. The publication of Government statistics on-line, monthly meetings of Parliament and open meetings of the Development and Planning Commission and the GHA Board are all part of this framework for greater access to information by the citizen.

There are a number of commitments which are obviously on-going, some have been actioned and others are at different stages of implementation.

The Deputy Chief Minister Dr Joseph Garcia, whose office is charged with the supervision of manifesto commitments said:

"The Government is delighted with our achievements so far after only 12 months in office. There are obviously a number of other commitments that are in the pipeline and which will be given effect to soon. The vast majority of commitments are for implementation over a four year term of office and this remains our objective. The Government is very grateful to the many public servants who are assisting in the delivery of our exciting programme of Government."
