2. (a) Purpose of tender is to provide new hard landscaped recreational promenades, playgrounds and vehicular parking, with new building works to provide associated tourist, sport and leisure facilities.
3. Period for completion should not exceed 22 months from date of award of the Contract.
4. (a) Contract documents may be requested from Mr Lionel Victory, Head of Procurement, Procurement Office, Unit 93 New Harbours, Rosia Road, Gibraltar.
5. (a) The final date for the receipt of requests for documents is Friday 26th October 2007.

(b) The final date for the receipt of tender is **12 noon on Friday 2nd November 2007**

(c) Tenders should be drawn up exclusively in English and delivered to No 6 Convent Place, Gibraltar and placed in the Tender Box situated on the ground floor of the building.
6. No deposits or guarantees required at this stage but the Authority reserves the right to require deposits, guarantees or other forms of appropriate security.
7. Terms and payments will be strictly in pounds Sterling (GBP) and as contained in the Tender documents
8. If the economic operator is a grouping, precise information on the legal form taken by the grouping is required. In the case of a consortium a legal entity will have to be formed before entering into a contract

9. Qualifications: The economic operator must prove its financial and economic standing and its ability and technical capacity by furnishing:
 - (i) Audited accounts for the past three financial years including a statement of the turnover of the business and the turnover of the the works;
 - (ii) A list of similar sized or larger assignments of a similar nature and complexity completed within the last 5 years;
 - (iii) A certificate of registration, issued by the Authority administering the official lists of the appropriate professional or trade registers
 - (iv) A certificate issued by the relevant competent Authorities attesting that the economic operator has fulfilled its obligations relating to the payment of social security contributions and taxes under the law of the relevant State in which the economic operator is established.
10. Tenders may lapse after 90 days from 2 November 2007.
11. Award criteria: The most economically advantageous offer received in terms of the criteria stated in the tender documentation
12. Variants will not be accepted
13. The Contracting Authority does not bind itself to awarding to the lowest or any tender received and does nto accept liability whatsoever for any costs or expenses incurred in the preparation of the tenders whether or not successful.
