Introduction

- The Civil Aviation (Air Navigation) Regulations 2009, Regulation 39, details the requirement that any person who wishes to act as the organiser of a flying display must obtain permission from the Director of Civil Aviation (DCA). The Civil Aviation (Air Navigation) Regulations 2009, Regulation 93, details the requirement for the DCA to issue permission to an operator to undertake aerial photography, aerial survey or any other form of aerial work over Gibraltar. Retained European Commission Regulations No 923/2012, SERA 3105, SERA 5005(f) and SERA 5015(b) detail the low flying prohibitions relating to Gibraltar and the circumstances in which exemptions to these prohibitions are applicable.
- 2. This procedure sets out the information required by the DCA in order that he can consider requests for permission or exemptions for special events and unusual aerial activity under the Regulations detailed above.

Applications

3. Applications for permissions or exemptions to undertake special events and unusual aerial activity, along with the required supporting documentation, should be received by the DCA a minimum of five working days before the date of the intended activity. Applications should be completed on the form attached at Annex A.

Decision of the DCA

4. Once the DCA has considered the application, taking into account the views of any agencies that might need to be consulted, the applicant will be informed of the decision of the DCA. If the application is approved, the DCA will contact the Airfield Authority to instigate NOTAM action for the specific activity.
