NOTES

GENERAL

1. Under the Town Planning (Control of Advertisements) Regulations 2018 the display of advertisements requires consent. There are certain exceptions, the details of which are set out in the Town Planning (Control of Advertisement) Regulations, 2019.

DRAWINGS REQUIRED

- 2. All applications should be accompanied by an appropriate scaled drawing(s). Drawings should:
 - a) Show the size of the advertisement and its position on the land or building in question.
 - b) In the case of a sign, indicate the materials to be used, fixings, colours, height above ground level and, where it would project from a building, the amount of projection.
 - c) Include the **site location plan** which need not be drawn to scale but should have sufficient detail to enable the site to be identified.

DESCRIPTION OF SIGNS, SIZE AND ILLUMINATION

- 3. The following must be shown:
 - a) The type of each sign for which application is being made, e.g. fascia, projecting, box, pole-mounted, free-standing;
 - b) The dimensions of each sign;
 - c) If any of the signs is to be illuminated, the type of illumination, e.g. internal, external, floodlight, etc., and whether the illumination will be static or intermittent.

OWNERS CONSENT

4. It is a condition of every consent granted under the Regulations that, before displaying any advertisement, the permission of the owner of the land or other person entitled to grant permission must be obtained.

FEES

5. A fee is payable for any application for advertisement consent. Following submission of your application an acknowledgement letter will be sent to you setting out the fee payable and a separate payment link will be sent via which online payment can be made. The application will not be processed until payment has been made.

THE RIGHT OF APPEAL

An applicant has a right to appeal against the decision of the Development and Planning Commission to refuse consent, or to grant consent subject to a condition with which the applicant is dissatisfied.
