Therefore, if you are tax resident in more than one country please detail all countries of tax residence and associated tax identification numbers.

Completing this form will ensure that we hold accurate and up to date information about your tax residency. This form will remain valid unless there is a change in circumstances relating to information, such as the account holder's tax status or other mandatory field information that makes this form incorrect or incomplete. In that case you must notify us and provide an updated self-certification declaration form.
