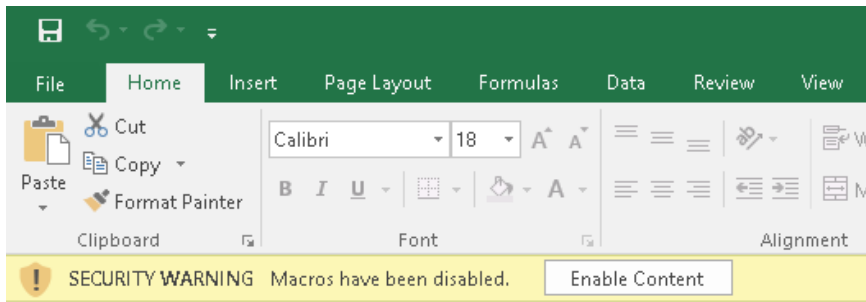
1. File Location

The P8 upload service can be found via the website link <https://tax.egov.gi/>

2. Security Warning: Macros have been disabled

When you download excel that contain macros, you may get a security warning message which you need to address before you will be allowed to edit the file.

Upon opening the downloaded file in Excel you may get the following warning:



If this warning appears please click 'Enable Content'. Doing so will allow you to work with the document and enjoy the added benefits this will provide you in your journey to completing and submitting a P8 to the Income Tax Office. - If no salary was paid to any employees or directors, given that you are still required to submit a nil return under the Income TAX (Pay as You Earn) Regulations 1989, click on 'P8 Nil Return'.
- Please note that once you make the selection on the type of P8 return you require, you will not be able to change and will need to open a new file. Should this transpire no previous information will be saved and you will need to re-start the process. This will not prevent you from amending any changes to your employees once the choice has been made.**

- Throughout the form you will have the following options available



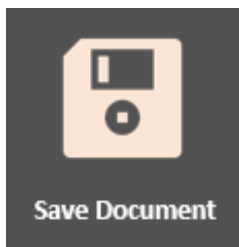
This option allows you to view the document in 'full-screen' mode, in which you can view more information. Please note that this option will depend on the size and resolution of your device.



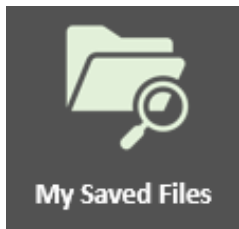

3.) Employer's Reference**A0999**

Please insert the PAYE Employer Reference number in this field. This is a letter followed by four numbers. An incorrect PAYE Employer Reference will result in an error message and may result in the submission being rejected. In this section you are required to provide the details of your employees:

5. Taxpayer Reference

You may obtain this from the Employee's PAYE Allowance & Social Insurance Class Certificate; Form P3 provided by the PAYE Section. If you are not sure what the Employee Reference number is, the employee will need to contact the PAYE Section on 200 74924 or via email paye.enquiries@gibraltar.gov.gi. to obtain this information. The PAYE section will be able to provide an employer tax code listing. Please note that if this information is not correct it could result in the P8 being rejected.

6. Surname(s) & Forename(s)

Please enter the name of your employee as shown on the Employee's PAYE Allowance & Social Insurance Class Certificate; Form P3 provided by the PAYE Section. If this information does not match our records it could result in the P8 being rejected.

7. Type of Salary

This field will provide a drop down list of the options available.

- INCOME - if the Employee is receiving a normal salary;
- DIRECTOR - if the Employee is a Director and is receiving director's fees;
- PENSIONER - if the Employee is receiving a pension;
- STUDENT - if the Employee is a Student on temporary employment with you. Applications for Student exemption should be sent to sicontributions@gibraltar.gov.gi. A terms of engagement in addition to a confirmation letter from the University / School / College highlighting that the individual is in full-time education must accompany your application.
- UNDER 30 DAYS - Section 19 - An Income from Occasional Presence in Gibraltar Form <https://www.gibraltar.gov.gi/income-tax-office/individuals-and-employees/payee> in addition to confirmation of defined travel periods to and from Gibraltar together with a signed affidavit to support this claim. This information must be submitted to paye.enquiries@gibraltar.gov.gi
- TAX EXEMPT – if the Employee is receiving income stated by Income Tax Office to be taxed at 0%

You should only show weeks the employee has received earnings. Do not enter unpaid weeks, for example, if in week 14, no salary has been received, the summary should show the split from week 1 to 13 and then a second entry as from week 15 to 52. As per current practice, any change to the social insurance contribution class code, must show a new entry from that week i.e. ER (Earnings Related) Week 1 to 40 as one entry and then Week 41 to 52 as PN (Pensioner).

9. Contribution Class Code

10. Total Weekly Contributions

Enter the total contributions in respect of the payment period. For example, if the payment period stated Weeks 1 to 40, the total weekly contributions should equal 40.

Enter the total amount of contributions paid by the employer.

13. Total Employee / Employer Contributions

This figure should be the total sum of both Employee & Employer contributions.

- Timothy Bloggs worked the entire year on the same social insurance code. All details in relation to his social insurance contributions, gross salary and tax deducted is placed on a single entry line.
- Mary Jones was issued with a Student Exemption by this office and was exempt from Social Insurance and PAYE for the tax year. Although her gross salary must be declared, no social insurance contributions or PAYE tax is deducted from these earnings as a student. **To receive the exemption, Terms of Engagement and Proof of Full Time Education should be sent to sicontributions@gibraltar.gov.gi**
- John Joseph was on an 'Earnings Related' Social Insurance code until week 48 when he attained the age of 60. A second entry is then created to declare weeks 49 to 52, for which his contribution class code was changed to 'PN (Pensioner)'.
- Josephine Frances ceased her employment in week 12 of the tax year. All relevant Income, Social Insurance and Tax for this period are declared as above in a single entry line.

A new entry must always be opened for any change in Social Insurance Contribution.

In this section you need to state the total amount of Benefits in Kind you may have provided as an Employer to your employees. If you have paid the tax for these amounts as an Employer the total amount that you have already submitted to this office should be declared. If the liability falls under the employee the total tax already paid should remain at £0.00.

Q. What is a Benefit-in-Kind (BIK) and how does it affect my tax position?

A. A Benefit in Kind is something provided to an employee by his/her employer at no cost to the former, which either has, or is capable of having, a monetary value. Examples of this include, Health Insurance, Food Vouchers, Clothing Allowances or even a Vehicle Purchased by the Employer for an Employee's private use. This value will be included as part of your taxable income at assessment time, and could increase your tax liability. However, the first £250 worth of benefits will be tax exempt. Taxpayers on the Allowance Based System can opt to have their tax code adjusted by the value of the BIK received. Alternatively, you can opt to add the value of any BIK received to your declared salary or wages. This will result in the benefit being taxed at source.

Q. Can my employer opt to pay the tax due on my Benefit-in-Kind on my behalf?

A. Yes. Your employer can opt to pay the tax due on any benefits provided by him/her on behalf of his/her employees.
