- 4. Participants must complete an entry form which is available for collection from the Department of Equality, 14 Governor's Parade or by emailing equality@gibraltar.gov.gi.
- 5. All entries must be received no later than 4pm on Monday 3rd February 2020.
- 6. All entries submitted must be the original work of the participant and must not have been published previously. It is the responsibility of each participant to ensure that their entry (or entries) does (do) not infringe the intellectual rights of any third party or any laws.
- 7. Subject to paragraph 8, rights in respect of all entries submitted for this competition will remain with the respective participants.
- 8. However, in consideration of HM Government of Gibraltar providing the competition, each participant grants a worldwide, irrevocable, perpetual license to H.M. Government of Gibraltar or their agents to feature any or all of the submitted entries in any of their publications, their websites and/or in any promotional material, including photos with the winning entrants connected to this competition without payment to the participant. In the case of winning participants in each category the license granted in accordance with this paragraph shall also be exclusive.
- 9. Only two entries may be submitted per person. Late and/or incomplete entries or entries not meeting the specified criteria will not be accepted. No responsibility can be accepted for lost entries and proof of transmission will not be accepted as proof of receipt.
